Scholarships and Donor Advised Funds

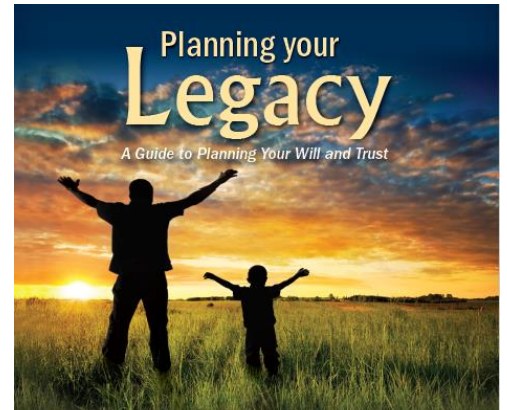
Would you like to create a scholarship fund in memory or honor of a loved one, your church or a favorite ministry? GUMF can help you establish and manage endowments and donor advised funds.
