Before Rev. Jack R. Bozeman passed away in 2013, he invested the lion's share of his family's retirement savings in the Georgia United Methodist Foundation's Certificate Program. In one of his last conversations with his son, Rev. Dr. Kirk Bozeman, he instructed him to take care of his mother, Jackie, and to make sure that their funds were invested in a way that would honor God and would honor him.

"My father served as a pastor and former district superintendent with The North Georgia Conference for 40 years. He was one of the finest, smartest, most faithful men I ever knew. He believed that the first 10 percent of all income goes to God and the second 10 percent goes to savings," said Bozeman, retired elder and supply pastor to Mt. Gilead UMC and Big Springs UMC in Woodstock.

"Before investing, he would question whether the company shared the same moral values and goals as he did. He believed deeply in the ministry and work of GUMF."

Bozeman serves as his mother's power of attorney. "Caring for my mother's physical, financial, and spiritual welfare is a top priority. With GUMF, we are able to keep our faith component active in our investing and still receive the best returns that we can find. The Church benefits because our funds are used to provide loans at extremely attractive rates, and GUMF benefits too," Bozeman said. "Our investment strengthens the Foundation; the Foundation strengthens another church; that church strengthens its membership and community through its ministries, and in doing so, strengthens the kingdom of God."

With life's unpredictability, Bozeman finds comfort in knowing that he would have easy access to his mother's short-term fixedrate certificate investments in the event of an emergency. Bozeman also noted that one of the greatest aspects of working with GUMF is the relationship. He knows he can call the office anytime and someone will always be available to answer his questions and provide guidance.

"When I was going through the ordination process with The North Georgia Conference, I was asked if I was doing this because of my father. I explained that it's not my job to erase his shadow but to extend it," Bozeman said. "And this is what we have done with GUMF. As time has gone by, we have added other funds so if my mother needs something, she'll have it."

Lending Makes a Kingdom Impact

hen it comes to your church's or ministry's financing needs, the Georgia United Methodist Foundation always has your best interests at heart. Thanks to your investments in our Certificate Program, we have loaned over \$31 million to Georgia United Methodist churches and related ministries. Four of our lending partners explain how their loans are making a kingdom impact in the communities they serve.

Refinance Saves Church \$18,000 Each Year

Transformation UMC in Hephzibah began its mission as a church merger but instead became a new church start. "In 2008, the Church decided to build.

Their prior mortgage was a 5-year adjustable-rate amortized over 15 years with a constant variable rate and a large balloon payment at the end of every five years," said Rev. GiGi A. Warren, senior pastor of Transformation UMC. "When I was appointed in 2018, I made loan refinancing a priority. I knew from previously serving in various roles within the annual conference that the Georgia United Methodist Foundation would be our best rate option. Our mortgage debt has dropped and provided an annual savings of \$18,000, which has been a blessing to our church. We have been able to set aside funds for our children and youth ministry, attend to deferred maintenance needs, and upgrade our external marketing strategy to the community. I am so thankful to GUMF for helping us continue God's kingdom work."

Restructured Loan Helps Church Focus on Mission

When the Korean Church of Newnan UMC began construction of its new building in 2012, the Church turned to the Georgia United Methodist Foun-

dation for a construction to permanent loan. Unfortunately, the Church ran into some unforeseen construction challenges. The resulting cost overruns substantially increased the Church's original loan needs. "In August 2019, we met with Jim Pope, GUMF director of lending, and Rev. Hyo Kim, The North Georgia Conference Korean/Asian church development consultant. GUMF helped us restructure our payment plan in a way that has been very beneficial to the Church moving forward," said Rev. Sungwon Nam, senior pastor of Korean Church of Newnan UMC. "We are very grateful to GUMF for the many ways they have blessed our church and eased our financial situation so we can focus on our mission of making disciples of Jesus Christ for the transformation of the world."

Loan Enhances Residents' Quality of Life

Wesley Woods Senior Living is committed to creating communities of connection, well-being, and promise for the 1,800 Georgia residents they

serve. In 2019, the aging roof and windows in their St. John Towers community in Augusta were beginning to leak and cause moisture build-up issues. Terry Barcroft, president and chief executive officer of Wesley Woods, knew they needed a lender they could trust that also offered an attractive rate and terms, flexibility, and low closing costs. "The Georgia United Methodist Foundation has allowed us to spend the money where we needed it to be spent – on the residents – not on banker's fees. They have also protected us from any payment application mistakes from the contractors. We have replaced the roof, windows, window treatments, flooring, and toilets. Our residents are now able to enjoy their home without the threat of leaks or water penetration," Barcroft said.

New Parking Lot Improves Safety and Curb Appeal

In 2017 when Rev. Tom Dent was appointed senior pastor of Trinity Pooler, he quickly recognized one of the Church's gifts was making people feel at

home. Together, they developed a new mission statement, improved their website, created a new logo that incorporated their beautiful stained-glass cross in the sanctuary, and repaved the aging parking lot, which was beginning to become dangerous. "Although we had no debt and could have funded it ourselves, we decided to preserve capital, and finance it through the Georgia United Methodist Foundation. We already have money invested with them and were pleased with both the interest rate and terms. It was a win-win situation that benefited GUMF and our church," said Dent. "Our new parking lot is safer for our congregation and communicates to the community that this church is committed to being here. I live in the parsonage behind the Church. Every day I walk over there I say, 'Thank you, Jesus!'"

Making Higher Education More Affordable

The Georgia United Methodist Foundation partners with donors, the Georgia student's United Methodist church, participating United Methodist-related schools, and the United Methodist Higher Education Foundation to award United Methodist Dollars for Scholars scholarships valued at up to \$4,000 each year. Since 2011, we have awarded 729 scholarships totaling \$601,700. Meet eight of our 75 students who received scholarships for the 2019-2020 school year.

Endowment Carries on Educators' Lifelong Legacy

y parents, Coach Fred and Peggy Ann Tucker, were married 60+ years. They met at a movie theatre in Tifton. Given that my dad was 12 years older, mom first rebuffed his offers but was finally convinced by her friends that he was a good catch. He was a coach and teacher and drove a pink Cadillac. When he called her back a few weeks later, she agreed to a date. The rest was history.

Both mom and dad were lifelong educators. Between the two of them, they taught or coached over 10,000 students over 70+ years in Randolph, Tift, and Berrien counties. A teacher and coach have an outsized amount of influence in a small town, and they influenced very many.

They both considered teaching to be their calling, and they took it seriously. At the same time, they didn't take themselves too seriously and remained unfailingly good-natured, unpretentious, and generous throughout their lives.

Both mom and dad grew up in the Depression. This difficult past could have made them both hard and brittle. But in them, it did the opposite. They were both generous to a fault, and while not wealthy, they were extremely giving and ready to assist with all kinds of causes.

My folks were doers. They thought of their work teaching and coaching as an extension of their faith. Mom and dad thought that character development

was maybe the most important thing they could impart to their students. And while my dad could lay it on thick with the rules and regulations, he understood those were a means to an end – not the end itself. This was how they shared their faith.

Besides their work in education, they were stalwart members at the United Methodist church in whatever town we lived. Dad taught Sunday school. Mom worked with the children's ministry and played piano for various groups at church.

It took our family by surprise when my mom passed away before my dad. When she died, we were very worried about my dad's ability to get through each day. He was still in good health and mind but was lost without my mom. My brother Greg and his wife, Kelly, stepped up and took great care of him until he died in 2019.

After my mom's death, our family established the Peggy Ann and Fred Tucker Scholarship Endowment with the Georgia United Methodist Foundation. My dad was the first to go to college in his family. He had the good fortune to get a football scholarship at Georgia Military College in Milledgeville during the 1940s. He did whatever it took to make ends meet and stay in college. And while my mom's circumstances were not as dramatic, she taught countless thousands of children of all ages for almost 50 years.

My dad saw this endowment as a chance to give a student the same opportunities that he had. Given their history and livelihoods, our family thinks it's the perfect continuing legacy to celebrate their lives.

Cemetery Association Preserves Final Resting Places



hen you walk through Tuckston UMC Cemetery in Athens, it is hard not to feel a mix of emotions. Grief as you think about the lives already lost; gratitude for the veterans who proudly served their country; and a sense of love, peace, and wonder knowing that Jesus, the Lamb of God, conquered sin and death and that one day believers will see their loved ones again.

In 2018, Tuckston UMC formed and incorporated a cemetery association separate from the Church to oversee the management of the cemetery. Accumulated funds previously earning minimal returns at a bank were invested with the Georgia United Methodist Foundation.

"The cemetery needs to be maintained not only because it is part of our church campus but also out of respect for the saints who are buried there," said Randy Bramlett, treasurer and board member of Tuckston Cemetery LLC. "By investing with GUMF, our goal is to earn more so that we will be able to use the earnings to pay for maintenance, which includes grass cutting and landscaping. It is good to have an organization like GUMF for these purposes."

Helping Members Leave a Legacy





June 2020 marks the fourth anniversary when one historically black and two historically white congregations in Savannah merged to become ConneXion Church. Rev. J. Michael Culbreth, senior and founding pastor, shepherds this intentionally multiracial and multigenerational church which seeks to demonstrate to the world how racial walls causing separation can be destroyed.

Like any committed pastor, Culbreth is concerned about his flock's current and future well-being. He recognized the need for a Wills Clinic after Rev. Steve Waldorf, former regional vice president at the Georgia United Methodist Foundation, provided an overview of GUMF's training programs and ministries.

"When it comes to estate planning many of our members need assistance with their wills. Since a large segment of our congregation is elderly, there is also a need to address planning for long-term care, senior living, and other matters," Culbreth said.

In December 2019, ConneXion Church invited other congregations and people from the surrounding community to attend a Wills Clinic led by Nancy Young, GUMF vice president of development. Nearly 60 people participated in the two-hour long program.

 Rev. J. Michael Culbreth, ConneXion Church Senior and Founding Pastor Culbreth noted that the feedback the Church received was positive and that all of the participants gained invaluable information on wills and the estate planning process, which they are planning to use as they prepare for the future.

"The primary takeaway was that everyone needs to engage in endof-life planning. Everyone needs a will yet many people have neglected to prepare for the future. By having all the documents in place before a crisis occurs, family members can find important documents when needed, which lessens the stress." Culbreth said. "GUMF's Wills Clinic was extremely helpful because it challenged everyone to prepare a will, to take care of other important legal matters, and to consider what legacy our members will leave their families and the Church. This is important because leaving a legacy to the Church is an easy way for members to help the Church remain strong. It also enables the Church to engage in ministry and outreach."

Culbreth believes having an estate plan in place is a sign of good stewardship because it enables a person to wisely use the resources God has placed in his or her hands. He also noted that having an estate plan is a great way to honor God with their resources.

Endowing the Church's Future





Empowering Women Through Recovery

hen your mission is transforming the lives of women and their children struggling with alcohol and drug addiction. every dollar invested matters because lives are at stake.

"Breakthru House provides a longterm residential program to empower women to experience physical, emotional, and spiritual healing through recovery. Breakthru House was the first program in the State of Georgia to be licensed as a gender-specific treatment program for addiction and mental health. Last year, we celebrated 50 years of service to our community," said Executive Director BreNita Jackson. "Breakthru House uses investment funds managed by the Georgia United Methodist Foundation to support the addiction and mental health treatment and services to women who have no means to afford these services. GUMF leads with faith and Christian values. The

professional and knowledgeable staff always goes the extra mile to provide excellent services."

Rev. Darci Jaret graduated from Breakthru House in 2012. It was in this community that she began a journey toward recovery and becoming a pastor. After recovering from assault and a suicide attempt, Jaret spent time at Breakthru House confronting self and developing practices of self-care that today still help her maintain recovery.

While at Breakthru House, Jaret was baptized and became a member and

administrator at First Baptist Church of Decatur. While working there, she received a call to ministry to lead people in creative expression. Jaret went back to school and received a Master of Divinity from Candler School of Theology in 2017, focusing on pastoral care through art-making. She currently serves as the pastor of worship, arts and advocacy at Park Avenue Baptist Church. Each week, Jaret hosts a creative spiritual group at Breakthru House. Giving back keeps her grounded and focused on remembering what it was like to overcome homelessness and begin recovery.

Special Gifts Shape New GUMF Program

e have been working on the **Clergy Financial Literacy** Academy Program for two years," says Georgia United Methodist Foundation President/CEO Rev. Keith E. Lawder. "We want to help clergy develop better financial leadership skills for the challenging days ahead."

Charles W. Buffington Jr., GUMF trustee and personal finance author, brought his considerable talents and enthusiasm to help staff develop a prototype for a threeday seminar. With gracious help from Dr. Derek W. McAleer, The South Georgia Conference treasurer and director of administrative services, GUMF piloted the program in early fall 2018. GUMF presented the overwhelmingly positive feedback to The North and South Georgia Conference Cabinets, which indicated the need for the program exceeded GUMF's capacity to

conduct in-person seminars.

GUMF's next step was to develop an electronic delivery system for presenting financial literacy tools to pastors. With the help of grants from The North Georgia Conference, Wespath Benefits and Investments, the Lilly Endowment, Inc., a trusteed endowment from SunTrust Bank, and lots of time and expertise from Buffington, GUMF's CFLA Program should be available this summer.

Clergy will learn the basics of personal and church finance via electronic notebooks, skill summaries, and reviews. Then while working in small groups, they will participate in case exercises to illustrate how to use the tools for better financial

decision making.

Buffington said, "Pastors will get to learn at their own pace and apply what they learn in small local discussion groups without having to travel or spend a large block of time away from home." McAleer added, "This critical material is an economical alternative to in-person meetings while respecting the clergy's time."




