# LaGrange College Alumni Lead Scholarship Endowment Drive to Honor Retired Professor

new scholarship endowment, named in honor of Dr. C. Frank McCook, has been established with the Georgia United Methodist Foundation (GUMF). McCook spent 33 years serving as a professor and Department of Religion head at LaGrange College until his retirement in 1994.

Kathy McCollum, LaGrange College and GUMF board of trustee, and Rev. John Haney, pastor of Pitts Chapel UMC in Macon, are jointly leading this endowment drive on behalf of other

LaGrange College alumni. Once fully funded, the \$20,000 endowment will generate a \$1,000 scholarship each year in perpetuity to benefit LaGrange College students.

"I was shocked. I was humbled, and I did not feel that I was worthy of this honor," McCook said. "My passion has been improving Christian education. I'm humbled to know that I will be assisting students in their educational process."

McCook's wife Elaine adds, "Frank is a firm believer in the Wesleyan ideology and philosophy and that educating yourself is important so that you never stop questioning and growing your faith and trying to reach a higher level."

A retired ordained minister with The South Georgia Conference, McCook holds a doctorate in Christian education. In 2016, he was named an honorary alumnus of La-Grange College. During his career, McCook helped to prepare students for ministry, led several groups of students on study abroad programs in Israel, and created the "Yes Project" to train students.

McCook also served as a supply pastor to several United Methodist churches and as chaplain to both Clan Donald USA and the Stone Mountain Highland Games. "I felt that the Word of God was an essential part of the human experience," he said. "I wanted these organizations that I was involved in to realize that they had a higher calling."

Haney has stayed in touch with McCook for over 40 years. He believes the scholarship endowment is a fitting tribute to a professor who impacted so many students' lives.

"Dr. McCook believed in me. He encouraged me, and he affirmed me. He helped me to reach my potential," Haney said. "Dr. McCook also gave me a wonderful love for Israel. When I went there with him for the first time, I got sick. He took care of me throughout the night. I'll never forget that for as long as I live."

To date, McCollum and Haney have raised nearly \$7,000 of the \$20,000 needed to endow this scholarship. Grants of \$1,000

McCollum noted that a scholarship honoring McCook's first wife, Louise, was created in the 1980s. On several occasions, McCook and his wife Elaine had the opportunity to meet the scholarship recipients. She also noted that the cost of a private college education is high and that these scholarships help present and future La-Grange students meet some of these costs while honoring the legacy of Dr. McCook.

# **Action Ministries Launches End Hunger Period Initiative** to Feed 10,000 Kids in Georgia Year-Round by 2024

he Georgia United Methodist Foundation always gets excited whenever a donor establishes a charitable gift to benefit Action Ministries. Since 1963, Action Ministries has been mobilizing communities to address the challenges of poverty by focusing on hunger relief, housing, and education.

In the Fall of 2019 a new initiative, End Hunger Period, was kicked off under the leadership of Kelley Henderson, former chief executive officer of Action Ministries. In this Q&A, Shakura Conoly, chief community engagement officer for Action Ministries, talks about End Hunger Period, which will positively impact thousands of children's lives.

#### Please tell me about this new initiative.

End Hunger Period is designed to close the meal gap for thousands of children across Georgia. Currently, our summer feeding program-Smart Lunch, Smart Kid-feeds 7,000 kids Monday through Friday. Our weekend meal programSuperPacks–feeds 2,500 kids every weekend during the school year. Our goal is to bridge the gap of these two programs and expand our footprint in high-need areas to ensure access to food and to feed 10,000 kids yearround by 2024.

#### Why is End Hunger Period so imperative?

One in five children in Georgia suffers from food insecurity. This rises to one in three children in rural communities. Georgia has the 10th highest food insecurity rate nationally. Hunger negatively effects the physical, social, emotional, and cognitive development of children.

#### Do you ever encounter stories that break your heart?

Yes. We provide our Smart Kid! After School programming and food supplies to students at Green Acres Elementary in Smyrna. In one of our partner stories, Principal Ashley Mize shared how a student came up to her with tears in his eyes. When she asked what he needed, he said that he was hungry and that it was not his turn to eat last night. Apparently, he came from a family of six or seven children, and they often didn't have enough food to feed all of their kids at night so they took turns.

#### How can we partner with Action **Ministries to End Hunger Period?**

This initiative relies on community partners and volunteers from all sectors to ensure our local kids get fed. Whether a group wants to do a peanut butter drive at work or at church, prepare and deliver meals to students in the communities where they live, or work with our team to host a fun volunteer event such as packing meal kits for kids, we have a place for you. You can also sponsor a child for \$400 to help end hunger throughout the entire year. # **Upon My Death Checklist**



ev. Grady Mosley, who is an ordained elder and has served as a pastor in The North Georgia Conference for 37 years, has written an excellent booklet on planning your end-of-life decisions. He emphasizes that leaving your wishes in writing is a faithful and loving gift to those whom you leave behind. What follows is a checklist based on Mosley's text.

Make sure you have recently completed advance directives and health care power of attorney forms. These let your loved ones and your doctors know your wishes in the event you cannot tell them.

Leave written instructions for what to do with your body after you pass. Do you wish to be buried or cremated? Do you wish to donate your organs? Have you made financial provisions to take care of your wishes? Do you have a cemetery plot or a place in a mausoleum?

Have you selected and met with a funeral director? Have you made provisions for the services you wish for them to perform? What sort of vessel do you desire for your remains or cremains? Have you prepaid or left provision for these services?

Have you written down your wishes for a service? Where do you wish for your service to take place? Who would you like to preside and/or speak? What are your desires for hymns and music? Do you wish for there to be an

open casket, a closed casket, an urn, or pictures? Are you a veteran or first responder, and do you wish for your service to be recognized?

- People may wish to honor you with flowers or a gift. Have you made your wishes known with regard to your favored charities?
- Have you let your loved ones know what sort of visitation and/or fellowship event you would like?
- Have you spoken to those who you wish to execute and represent your wishes in making these decisions? Have you told them exactly where your wishes are written down and how to access them when they need to? Have you notified the individuals you have appointed as executor(s) of your will and let those who will implement your final wishes know who the executor is?
